

Revenue & Expenditure Statements for 2024-25 @ 03/17/2025 (p.1 & P.3)

- The expenditure budget after eight and a half months appears to be on budget. Currently it is expected to have savings of (at least) \$250,000 due to open positions and benefits savings (medical). A few accounts in the police budget are over budget. An internal police budget transfer is forthcoming.
- Investment income will exceed the revenue estimate amount by \$700,000.

Investments (p. 12)

- Interest rates have remained relatively the same from January to February. The STIF rate went from 4.45% to 4.46%. Currently, on 03/17/2025, the daily STIF rate was 4.41%.

General Fund, Fund Balance @ 06/30/2025 (p. 13)

- The 06/30/2024 (audited) **unassigned** general fund, fund balance = \$15,664,487 which represents 24% of total (2024-25) budget amount. The estimated 06/30/2025 unassigned fund balance is \$14,069,022 which represents 22% of total budget. This assumes the budgeted use of fund balance of \$2,625,000 in the 2025-26 budget (before public hearing). 20% of the total budget equates to \$12,884,809.

Contingency Account (p.14)

- The contingency account has a balance of \$36,484.

General Comments

- An RFP was sent out for the annual audit. Two proposals were received.
